#### **Creative Commons Licences**

#### CC BY (Attribution Only)

This licence lets others distribute, remix, tweak, and build upon your work, even commercially, as long as they credit you for the original creation. Recommended for maximum dissemination and use of licensed materials.

# CC BY-SA (Attribution-ShareAlike)

This licence lets others remix, tweak, and build upon your work even for commercial purposes, as long as they credit you and license their new creations under the identical terms. All new works based on yours will carry the same licence, so any derivatives will also allow commercial use.

# CC BY-ND (Attribution-NoDerivs)

This licence allows for redistribution, commercial and non-commercial, as long as it is passed along unchanged and in whole, with credit to you.

# CC BY-NC (Attribution-NonCommercial)

This licence lets others remix, tweak, and build upon your work non-commercially, and although their new works must also acknowledge you and be non-commercial, they don't have to license their derivative works on the same terms.

# CC BY-NC-SA (Attribution-NonCommercial-ShareAlike)

This licence lets others remix, tweak, and build upon your work non-commercially, as long as they credit you and license their new creations under the identical terms.

# CC BY-NC-ND (Attribution-NonCommercial-NoDerivs)

This licence is the most restrictive of the six main CC licences, only allowing others to download your works and share them with others as long as they credit you, but they can't change them in any way or use them commercially.
