## Dear supporter of the Inspireurope project,

Aristotle University of Thessaloniki is proud to be one of 10 European partners that participate in the Initiative to Support, Promote and Integrate Researchers at Risk in Europe (InSPIREurope). This new initiative is coordinated by Maynooth University, host of the Scholars at Risk Network in Europe, and is funded by the Marie Skłodowska-Curie actions (MSCA) of the European Commission (Horizon 2020).

**InSPIREurope** begins from the view that excellence in research depends upon open scientific debate, and is driven by a multiplicity of ideas, people and perspectives. As pressures on academic freedom are growing around the world, so too are pressures on individual researchers. When researchers are at risk, and excluded from participating in the global research circuit, whether due to discrimination, persecution or violence, not only are individual lives and careers at risk – the very future of research is also at stake. **InSPIREurope** partners, sharing the same strong commitment to excellence in research and to the principles of freedom of inquiry and academic freedom that are essential preconditions for world-class research, have joined forces across Europe to strengthen support for researchers at risk.

Aristotle University of Thessaloniki will participate in all phases of the Initiative and will have a central role in the outreach activities throughout Central, Eastern and South Europe in support of researchers at risk.

## **InSPIREurope Objectives**

**Inspireurope** is a 3-year project (September 2019-August 2022) funded by the European Commission under grant agreement no. 857742. The project is led by a consortium of ten European partners active in supporting researchers at risk and is **coordinated by Maynooth University** (host of Scholars at Risk Europe). It also involves the global Scholars at Risk Network as an international partner as well as five associate partners across Europe.

Inspireurope aims to facilitate cooperation across Europe in support of researchers at risk and to increase opportunities for these researchers in the academic and non-academic sectors in Europe, via improved sharing of good practices, trainings and advisory activities, and policy recommendations on improving Europe-wide support.

### The project's objectives:

- Lay the groundwork for a long-term, cross-sectoral, European support structure for researchers at risk
- Contribute to informed policy-making in Europe on support for researchers at risk
- Bridge the gaps between national and European support mechanisms, between academic and non-academic sectors in support of researchers at risk.
- Improve career development opportunities for researchers at risk
- Prepare the work environment to receive researchers at risk
- Grow the diversity of actors supporting researchers at risk, in particular in Central, Eastern and Southern Europe, and inclusion of business/industry in outreach efforts

#### The project's main activities:

- Establish a European Coordinating Committee
- Map and analyse existing support, detailed policy recommendations and a road map for improving support.
- Mutual learning activities and high-level stakeholder fora to facilitate exchange
- Training and guidance for researchers at risk
- Training and guidance for employers, host organizations and other key stakeholders, academic and non-academic sector across Europe
- Outreach, networking and awareness-raising

## **Call for training experts**

As part of Inspireurope, three mutual exchange and learning events will take place at the annual Stakeholder Fora in 2020, 2021 and 2022 which will be held in France and Germany respectively. Topics for the training have yet to be confirmed but may include preparation of Horizon 2020 proposals, academic publishing, accessing the academic labour market in different European countries and more. ## First InSPIREurope Outreach Workshop Jagiellonian University, Poland 9.1.2020

On January 9<sup>th</sup> 2020, Jagiellonian University hosted a workshop in Kraków to introduce the Inspireurope project and to encourage more Polish organisations to get involved in supporting researchers at risk.

This inspiring and successful workshop gathered 17 project partners, 6 at-risk researchers, 26 academics from Polish universities as well as civil servants, local government representatives, students, journalists and members of civil society organizations. The workshop included:

- Plenary sessions open to the public on:
  - Academic Freedom and the importance of supporting researchers at risk
  - o Building a culture of welcome at Polish universities
  - Preparing the work environment for researchers at risk.
    Testimonials from researchers at risk
- Parallel sessions on:
  - InSPIREurope mapping & policy recommendations including a focus group with researchers at risk and on
  - the situation of international researchers working and studying at Polish HE Institutions as well as existing mechanisms facilitating their inclusion in the academic community.

Furthermore, invited researchers participating in the workshop had a space to present their current research. In order to fully appreciate the visit of researchers from different countries, on Friday 10, the Section of Feminist Sociology of Sociology Student Association organized a seminar on gender relations in the Middle East with their participation. The seminar attracted a great number of workshop participants and students from Jagiellonian University.

#### Mapping of existing support for researchers at risk in Europe

A key component of the Inspireurope project is to assess the effectiveness of existing measures in European and national research and innovation programmes in support of researchers at risk and provide recommendations on how they could be improved. A mapping of these support structures is underway, and consultation processes with stakeholders across Europe will soon begin.

### Survey and focus group discussions with researchers at risk

Inspireurope is conducting surveys and focus group discussions with researchers at risk to assess their experiences of European and national research funding and other support mechanisms, and to understand any challenges met in accessing them. The survey and focus group discussions will also gather input on how to improve the policy environment in Europe for the reception and integration of researchers at risk.
